Methodology

Poll number: pr2215

Interview Dates: September 2-8, 2022

Sample Population: 2137 adults in coastal counties the United States.

Sample Selection: Scientific online poll - stratified sample of panel respondents.

Weighting Parameters: The sample was weighted based on the U.S. Census Bureau's American Community Survey (ACS) for Adults (18+) in coastal counties in the United States based on age, gender, race, educational attainment, census region, coastal region and Hispanic ethnicity.

This topline provides weighted percentages, as well as the unweighted N-size for the total sample. Due to the effects of weighting and rounding, figures may or may not add up to 100%. The standard deviation of the weights was: 0.7390965. The maximum weight was: 5.1927839. The minimum weight was: 0.1945824. 95% of the weights were between 0.2926615, 3.3980522.

Margin of Error: The 95% credibility interval for this survey is +/- 2.6%, which includes the square root of the design effect (DEFT): 1.2433857.
